***Concession in Training Fee:***

SC/ST Candidates pursuing CPL Training in IGRUA are given concession in training fee as given below:-

- Up to 15<sup>th</sup> CPL Course, three SC/ST trainees in each batch were given 100% concession in training fee and the remaining SC/ST trainees were given 50% concession.
- From 15<sup>th</sup> CPL course till financial year 2007-08 (21<sup>st</sup> CPL course), concession in training fee is given to SC/ST trainees subject to a maximum of 20% trainees in each batch, whose guardian's income was less than Rs. 1.00 Lac per annum.
- Details of beneficiaries under all the above schemes are given in **ANNEXURE - I to Manual (xiii)**.

***Scholarship for Training:***

- From F/Y 2007-08, Ministry of Social Justice & Empowerment and Ministry of Tribal Affairs commenced award of Scholarship to five (5) candidates each of SC & ST category on merit cum means basis of IGRUA. The Ministry of Social Justice and Empowerment reduced the number of Scholarships from five (5) to two (2) from F/Y 2009-10 onwards.

Details of beneficiaries under the above schemes are given in **ANNEXURE - II & III to Manual (xiii)**.

***Other Concessions:***

- Concession in Application fee for admission in courses offered by IGRUA is given to SC/ST Candidates.
- Reimbursement of Traveling expenses by shortest route by rail in second class to SC/ST candidates is given for appearing in written test/interview for admission in courses offered by IGRUA.
